

1. From the President, Ian Davidson– Are you on Top of the ACOFS DVD Rights Agreement?

Judging from the queries we receive from time to time it is clear that not everyone is perfectly at home with the ACOFS Rights agreement, and what it covers (and does not cover) and how to go about finding DVD rights!

- The ACOFS DVD rights agreement is an agreement made between the cooperating DVD distributors in Australia with ACOFS (on behalf of all Member State Federations and their member film societies). It specifies that member film societies may screen their own copy of a DVD to their members providing they first get permission from the appropriate Australian rights owner, and then be charged an agreed rate for that screening. At the moment that agreed rate is \$50 + GST, although Roadshow have implemented a sliding scale between \$40 and \$100 (+ GST) based on the size of the society.
- The agreement only applies to DVDs and BluRays obtained separately by the film society. They may own the DVD or borrow it from a friend or DVD library. In some

- cases the DVD might be supplied by the relevant DVD distributor for a fee, but that is outside the scope of this agreement.
- The agreement does not cover 16mm or 35mm films or DCP (Digital Cinema Packages).
- The agreement applies only where the DVD is projected to members of the film society (ie a "non-theatrical" screening). Where members of the public are admitted, especially when charged for admission, it is considered to be a "theatrical" screening and the agreement does not apply. The exception is where limited numbers of potential members are permitted to "come-and-try" a film screening at no charge but that can only be a couple of times each!
- The agreement does not generally include outdoor screenings because it is usually difficult to segregate the film society from the general public.
- The agreement does not apply to titles booked from the SLA at the NFSA, nor when you hire a DVD from a company and that hire rate includes the rights.

"But how do you find the rights holder in the first place?" I hear you ask.

- A good place to start is the Censorship board database www.classification.gov.au
 If the title has not had censorship classification, then it is very likely not with any distributor in Australia. The listing however, often distinguishes between DVD, 35mm and DCP, with each being handled by different companies.
- Another source of information is the reviewers, some of whom state the distributors of the title they are reviewing eg Urban Cine-file. Some sales outlets also list the distributor on their website.
- Approach the relevant Australian distributor according to your findings. Even if they
 have the theatrical screening rights it does not mean they necessarily have the
 non-theatrical rights also. The distributor listed on the classification website or
 sales website may not be the company to contact as many are represented by
 other distribution agents. ACOFS Fact Sheet 3B, which is updated regularly, will
 give you the latest known contacts for all co-operating rights owners.
- See www.acofs.org.au/resources/ for your latest copy of Fact Sheet 3B (The latest version is dated 14th January 2016)
- Through a special arrangement, ACOFS handle the film society rights bookings for Madman titles. Contact dvdrights@acofs.org.au to book a Madman title.

Key things to remember:

- Get the rights agreed BEFORE promoting the title.
- If you screen it twice, pay the rights twice.
- You will generally be invoiced after the screening. Please pay promptly.
- Do your homework BEFORE approaching the distributors with dates and titles wanted. They do not have time to go through your "shopping list" of possible titles on the off chance they may handle some of them.
- If the rights are not owned by an Australian company or have "expired" in Australia, they have probably reverted to the international owner of those rights, such as the film production company. It does not follow that they are free to screen in Australia.
- Because film rights exist for the lifetime of the author of the title (ie director or producer) plus 70 years, very few film titles are in the public domain (ie no rights applicable). So unless you are certain, you should assume that someone, somewhere holds the screening rights for what you wish to screen.
- Approaching an overseas rights holder can have an unpredictable result. Most seem to expect a rights charge of 200 Euro (\$315) or more but if you are lucky you could find a director or producer happy to give you permission for free.

2. The ACOFS DVD Rights Agreement

The DVD rights agreement Fact Sheet 3B is constantly being updated as new distributors come to our notice or existing ones change their contact details. Download one today to keep up to date. www.acofs.org.au/resources/. There have been some changes to the contacts. The latest version was uploaded on 14th January 2016.

The ACOFS agreement applies only to fully paid up societies that screen DVDs non-theatrically (ie to members only) and only where the society sources their own copy of the DVD. The agreement does not cover supply of the DVD from the distributor, although the society may make their own arrangements in this regard.

If you screen a DVD as a fund-raiser, or admit general public (whether charged or free) it is considered a "theatrical screening" and you will need to approach the distributor for a quote for the screening rights as they are likely to be more expensive than the ACOFS agreed non-theatrical rights.

3. ACOFS AGM 2016

Current plans are that the 2016 ACOFS AGM will be held at the Courtyard Room, Whitehorse Civic Centre, 397 Whitehorse Rd, Nunawading, Victoria on Saturday 28th May 2016. It will be an all-day meeting (9:00am – 5:00pm) – lunch supplied.

There will be an opportunity for a social dinner after the meeting and if enough interest, a movie from the FVFS Indie Library.

Earlybirds should also be able to get together at 6:00pm on Friday 27th May for dinner.

4. News From the DVD Distributors

These are all the DVD distributors who are party to the ACOFS DVD rights agreement, under which member film societies pay special affordable prices for their DVD screening rights. As ACOFS' part of the agreement, we promote the distributor's catalogues and especially information on any new acquisitions. Information provided by the distributors since the last Bulletin is listed below.

Roadshow charge for their DVD rights on the basis of average audience size, so if you have not registered your membership size with your State Federation you may be charged DVD rights at the highest rate!

Some titles might only have commercial or home entertainment rights while other titles might be listed by Madman on behalf of other smaller distributors. So always check apparent Madman titles with dvdrights@acofs.org.au before committing to a screening, and give plenty of notice!
